- 2.) Increasing opportunities for housing density
- 3.) Development of mixed-use spaces that contributes to the pedestrian environment, creative placemaking, and economic vibrancy
- 4.) Increasing housing options for a variety of income levels
- 5.) Support in the City's housing in-fill strategy
- 6.) Creation of homeownership opportunities to support pipeline of eligible buyers (200 applicants)



	FINANCIAL CAPACITY	The Development Team must provide prior examples of how they secured the necessary funding. Including equity and debt capital to finance housing projects
<b>RFQ Evaluatio</b>	PROJECT TEAM QUALIFICATIONS	The Development Team must provide relevant experience for all persons and sub-developers who will be actively engaged in the project.
	PRIOR PROJECT EXPERIENCE	The Development Team must provide examples of similar, relevant projects completed by their organization within the last 10 years.
	STAKEHOLDERS & COMMUNITY ENGAGEMENT	The Development Team must provide examples of prior community engagement and stakeholders in the design and development of the project, as well as the long-term management of the project.
	DIVERSITY IN TEAM & PARTNERSHIPS	Provide examples of partnerships with certified Minority Business Enterprise/Women Business Enterprise (MBE/WBE), Disadvantaged Business Enterprise (DBE), or Black, Indigenous, People of Color (BIPOC) led Organizations.
